Councillor Morgan gave background to the subject. She has been in contact with BANES Traffic Management and the Assistant Engineer, had replied in the following terms "I regret that we under the Department for Transport Guidelines are unable to install and do not authorise mirrors on the adopted highway within our jurisdiction The use of mirrors can cause confusion to drivers as to the perception of speed, particularly in the dark, as it may be difficult to judge. There are also maintenance issues as cleaning and replacement of broken mirrors is expensive and we no longer have a budget allocation for such items.

I apologise that I cannot be more positive although I will look at the road markings to see if any improvement can be made prior to the bend. "

Cllr Morgan will liaise with resident concerned.
